TOURIST VISA INFORMATION (English)

All tourists have to apply for visa in advance. Send your documents altogether also in case of many applications (preferably as register letter, but NOT as "to addressee only"!). Tourist visa is for a stay of 4 weeks (28 days). An extension for some days is possible. For that, please request information after your arrival. After issue, visa is valid for **3 months to enter Myanmar once during this time (entry visa)**. Date of issue is determined by the time of application. From day of entry, visa permits a maximum stay of 28 days. Please consider that visa processing is lasting 2 to 3 weeks after receipt of application.

For application of tourist visa, you need the following:

1. Original passport (no copy!) still valid for 6 months at least
2. Two Application Forms for Tourist Visa. Please apply in English and, among others, mention your occupation/profession (or retired).
3. Two passport photos: Please glue (no clips, no staples) one photo yourself on each of the two forms
4. Visa fee of 25 Euro. Pay in advance by bank transfer (see bank details at the end of the page), or in cash. Please consider that a bank transfer from abroad can sometimes take up to 10 days so that issuing may delay. Refund of visa fee after issue is not possible.
5. Self-addressed return envelope with German stamps for registered letter. For international return mailings, enclose a postage fee of 10 Euro minimum in cash (**cheque and bank transfer are not accepted**). **International coupons for postage fee and Austrian stamps are not accepted.**

INFORMATIONEN FÜR TOURISTEN VISUM (Deutsch)

Ein Touristenvisum ist nur im Voraus zu beantragen. Das Visum ist ein Einreisevisum gültig für drei Monate ab Ausstellungsdatum. Innerhalb dieser Zeit können Sie einmal einreisen. Vom Tag Ihrer Einreise erlaubt es Ihnen einen Aufenthalt in Myanmar von 4 Wochen (28 Tage). Eine Verlängerung vor Ort ist möglich. Vor allem Überweisungen aus dem Ausland benötigen längere Zeit. Eine Rückerstattung der Gebühren nach der Visumbearbeitung ist nicht mehr möglich. **Wir bitten, die Formulare vollständig in Englisch auszufüllen.** Bitte beantragen Sie Ihr Visum rechtzeitig. Allein der Postweg kann manchmal bis zu 10 Tage in Anspruch nehmen. Nach Ankunft der Unterlagen dauert die Visumbearbeitung 2 bis 3 Wochen.

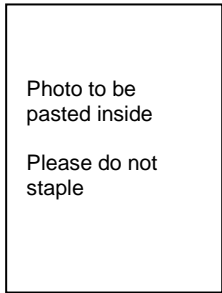
Folgende Unterlagen werden benötigt:

1. Reisepass (keine Photokopie!) mit mindestens 6 Monaten Gültigkeit
2. Zwei Antragsformulare für Touristenvisum
3. Zwei Passfotos: Kleben Sie bitte jeweils ein Foto auf eines der Formulare (bitte keine Klammern!)
4. Visumgebühr 25 Euro. Zahlen Sie die Visumgebühren im Voraus per Banküberweisung (Bankverbindung siehe unten) oder in bar. Nach Ausstellung eines Visums ist eine Rückerstattung nicht mehr möglich.
5. Einen frankierten (nur deutsche Briefmarken!) und fertig adressierten Einschreiben-Rückumschlag. Für Sendungen von ausserhalb Deutschlands müssen Sie mindestens 10 Euro für das Rückporto in bar beilegen (**Schecks und Überweisungen werden nicht akzeptiert!**).
Internationale Antwortscheine und österreichische Briefmarken werden von der deutschen Post nicht akzeptiert!

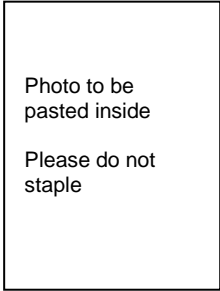
